



#### 1. EXECUTIVE SUMMARY

#### **Project Description:**

Work under this contract consists of safety/streetscape improvements along New Jersey Avenue, NW from N Street NW to H Street NW and the reconstruction New York Avenue, NW from First Street NW to 4th Street NW. The work includes but is not limited to the following items: Installation of new curb, gutter, and sidewalk; Installation of full depth pavement, Pavement resurfacing; Installation of utilities; Installation of flexible pavement; Installation of street light poles; Installation of traffic signals; Installation of signing and pavement markings; Installation of electrical duct bank; Relocation of over-height detection system; Installation of wireless vehicle detection system; Installation of landscape improvements; Installation of erosion and sediment control; Implementation of transportation management plan; Mobilization and demobilization, provision and maintenance of work and storage areas, Engineer's field facilities and performance of employee training; Removal and disposal of any material as a result of the activities listed above, unless stated otherwise in the contract drawings.

This project is 83.15% Federally Funded and 16.85% District-Funded. DDOT selected Capitol Paving of DC, Inc. (CPDC) as the contractor and awarded the \$12,055,691.00 contract on January 9, 2019. DDOT issued notice to proceed with contract work to CPDC with work to begin on 05/13/2019 and a substantial completion date of 11/23/2020.

#### 2. STATUS OF CONSTRUCTION / PROGRESS SUMMARY

Work this week was performed during the day on Sunday, October 18th, 2020 thru Saturday, October 24th, 2020. Please see the details below.

- Along NY Ave and Kirby St.
  - o 1 Steel Sign Structure was installed at this location.
  - 1 Overhead Sign Structure was removed.
  - 1 Unassigned Special Item-LS-Existing DMS was relocated.
  - o 279.500 SF Traffic Sign Panels were installed.
  - Removed 144.000 SF of Existing Ground Mounted Signs.
- Along NY Ave between 1st St. and M St.

  91.180 TONs of Temporary AC, HMA Surface Course, 12.5 mm was placed and compacted.
- Along NJ Ave between H St. and N St.
  - 55 Flexible Delineators for Bicycle Lane were installed.
  - 51 Unassigned Special Item-Each-Zebra Cycle Lane Separators were installed.
  - Removed 8 Traffic Signal Pole and Traffic Signal Equipment.
- Along NJ Ave between H St. and N St.
  - 23 Deciduous Tree 2-3" Cal, B &B Ulmus Americana (American Elm) were installed at various locations.
- Along NY Ave between NJ Ave and 4th St.
  - 183.340 TONs of HMA Surface Course, 12.5 mm was placed and compacted.
  - 2,366.000 SY of Pavement Profiling (Milling) was performed.
  - 3,197.110 SY of Tack Coat was placed.
- Along NJ Ave between K St and L St.
  - 22 Existing Ground Mounted Signs removed.
  - 3 SF of Traffic Sign Panels were installed.
  - 12.000 LF of Metal Sign Posts, 3.00 Pounds per Foot was installed.
- Along Pierce St. and N St.
  - 37 Flexible Delineators for Bicycle Lane were installed.
  - 28 Unassigned Special Item-Each-Zebra Cycle Lane Separators were installed.
- Along NY Ave and 1st St.
  - o Furnished and installed, 2,255.000 LF No. 6 AWG Stranded Wire.
- Along NY Ave between NJ Ave and 4th St.
  - 146.650 TONs of HMA Surface Course, 12.5 mm was placed and compacted.




